

## Pipeline Summit 2019

### Terms of Participation

Whenever in present Terms of Participation following defined terms are used, should be understood as follows:

**Organizer** – Pipeline Media Ltd. based in Gdańsk Science & Technology Park, Trzy Lipy 3 Street, 80- 283 Gdańsk, entered into the Register of Entrepreneurs kept by the District Court for Gdańsk, VII Commercial Division of the National Court Register under the KRS number: 0000598388, NIP: 9571083194.

**Conference** – an event Pipeline Summit 2019 produced by the Organizer, between 22nd and 23rd January 2019, in the Pomorski Park Naukowo-Technologiczny Gdynia, which is open to any person who meets the conditions of participation of these Terms of Participation and accept the regulations of these Terms of Participation .

**Participant** – a natural person entitled to participate in the Conference

**Application** – actions taken by the Participant to register to the Conference, consisting in filling the Registration Form.

**Registration Form** – form available on the website of the Organizer.

**Random Events** – circumstances, which, though maintaining due diligence, are unpredictable and cannot be prevented or counter effectively.

**Regulations** – this set of regulations meaning the set of terms of participation in Conference binding for all Participants.

**The right to information (information clause)** - information to which the Organizer, as Controller of Participants' personal data, is required according to art. 13 § 1 and § 2 of the General Regulation on the Protection of Personal Data of 27 April 2016 (hereinafter: GPRD).

1. A main condition to participate in the Conference is performing an Application by filling the Registration Form and paying the ticket fee.
2. Applications can be submitted electronically (online) on the Registration Form available on the website of the Conference: [www.pipelinesummit.com](http://www.pipelinesummit.com)

3. Application for participation in the Conference constitutes acceptance of these Terms of Participation and Participant's commitment to follow them.
4. The organizer reserves the right to make changes to the Conference's Agenda.
5. In the case of Random Events, organizer reserves the right to change the principles of the Conference organization, including the date and the place. In this case, the Organizer is obliged to inform Participants about change by e-mail to the address given by the Participant in the Registration Form.
6. The Organizer is not responsible for items lost or left behind by the Participant at the Conference.
7. Without the consent of the Organizer sound- and video- recording is prohibited.
8. Participants cannot personally relate to other Participants, speakers and conference Organizers in a manner that violates the dignity or contrary to general principles of social coexistence.
9. Participants are required to behave in a manner that is not disturbing for other Participants of the Conference.
10. The Participant shall bear full responsibility for the damages made by him on the premises of the Conference venue and satellite event venues.
11. The Organizer reserves the right to expel the participant who breaks the Terms of Participation.
12. Organizer have right to verify the identity of the Participant based on ID card with photo. The Participants are obligated to show their ID card at the Organizer's request.

## **TICKET PURCHASE AND USE TERMS**

### **§1 Payment and inclusion on the list of Participants**

1. Inclusion on the list of attendees is followed by receipt of payment on the Organizer's account. Purchaser shall be promptly informed by the Organizer of the fact of inclusion on the list of participants via email sent to the address given in the Application.
2. In case of Conference cancellation, the amount paid on account of the Organizer will be paid no later than 14 working days from the scheduled date of the Conference, to the bank account from which the payment occurred.
3. Electronic payments are provided by PayLane Sp. z o.o., located in Gdańsk at Arkońska 6/A3, zip code: 80-387, National Court Register - Company number: 0000227278. Transaction data, including personal data, can be transferred to PayLane Sp. z o.o. in order to process payments.
4. Payment can be made at the option of the Purchaser: credit card, electronic transfer, PayPal.
5. In case of refund, it will be made using the same payment channel as payment.

6. The Purchaser agrees to receive invoices via email only.

## **§2 Changing the Participants name**

1. In the case of absence of opportunities to participate in the Conference for reasons beyond the control of the Participant, the Organizer allows the opportunity to participate in the Conference another Participant designated by the Purchaser. The indication must be in the form of electronic mail item sent to: team@pipelinesummit.com and must be submitted to the Organizer no later than 5 working days prior to the date of the Conference. In case of failure to notify about a change of participant, Purchaser will be charged with the full cost of all services purchased.

## **§3**

### **Withdrawal from a purchase contract distance selling**

1. The Participant who is a Consumer has the right to withdraw from the contract for the purchase of a Tickets without giving a reason within 14 days of making the payment as a completed purchase.
2. To comply with the deadline for withdrawal from the agreement, it is sufficient for the Consumer to send a statement before the expiry of that period to the e-mail address: team@pipelinesummit.com from the e-mail address on the basis of which the participation in the Conference was registered.
3. In the case referred to in point 1, the Organizer upon receipt of a declaration of withdrawal from the contract for the purchase of a Ticket by a Participant, will block and then cancel the purchased Ticket in the sales system.
4. The Organizer will refund the price paid by the Participant for the purchase of the Ticket within 14 days from the date of withdrawal by the Participant to the bank account indicated by the Participant in the statement of withdrawal or in the absence of such data to the bank account from which the payment was made.
5. In the event that the date referred to in paragraph 1 shall expire on the day of the beginning of the Conference or later, the last day of withdrawal from the contract, shall be the day preceding the beginning of the Conference.
6. On the day of the beginning of the Conference, due to the start of the service in accordance with the date indicated on the ticket by the Organizer, withdrawal is no longer possible.
7. The right to withdraw is only granted to the person who bought the Ticket using the the e-mail address on the basis of which the participation in the Conference was registered. To exercise the right of withdrawal, there are no eligible persons for whom the Ticket has been transferred.

## §4

### Change of Regulations

1. The Organizers are entitled to change the Terms of Participation and this change becomes effective on the date indicated by the Organizer.
2. Information about the amendment of the Regulations is posted on the Conference website. If the changes are not accepted, the User should immediately notify the Organizer about the lack of acceptance of the changes to the address: [team@pipelinesummit.com](mailto:team@pipelinesummit.com) in order to terminate the contract.
3. The Regulations are made available to the Users free of charge and continuously on the [www.pipelinesummit.com](http://www.pipelinesummit.com) websites in a manner enabling the Users to obtain, reproduce, save its contents at any time.
